

# DISCIPLINE AND DRESS CODE:

The college follows a high level of discipline and all students are expected to maintain it.

## RAGGING IS AN INHUMAN OFFENCE AND IS STRICTLY PROHIBITED IN CAMPUS

### FOLLOWING MEASURES ARE BEGIN TAKEN TO CURB RAGGING:-

1. All the teachers are vigilant about ragging. If any student is found to involve in ragging, the management has rights to cancel of admission, suspension, rustication or expulsion from the Institute / Hostel. & report the matter to Parents for necessary action.
2. Students are advised to adhere to the dress code. White pant, white shirt, black shoes with laces, white apron. Black tie with college monogram. Jeans are strictly prohibited in college campus.
3. All the first year students are required to stay in a hostel for their safety. If they stay outside the college administration will not be responsible for any incident, if unfortunately, happens with them. Parents have to ensure their safety.
4. Wardens/Asst. Warden take regular round & surprise check up to prevent the ragging in the hostel.
5. Members of the anti-ragging squad will also take surprise rounds of possible lonely places of the college where there is the possibility of ragging.
6. The day scholars will assemble at a particular place for lunch & will take lunch together in the common room. The place will be kept under constant vigil by the college employees.
7. The day scholars are accompanied by an employee of the department up to the gate.
8. Hostel gates will be closed at 09:00 p.m. & no student will be allowed to leave the hostel without prior permission and gate pass of wardens/Asst. Warden.
9. Fresher should give the address & telephone no. of their parents and local guardian. Guardian is only real uncle, aunty. (Blood relation only).
10. Any student is free to lodge a complaint regarding the ragging in hostels with wardens or Principal at Toll-free nos.
11. Bunks from the classes will be treated as anti-disciplinary activity and suitable action will be taken. Parents are requested to kindly cooperate.
12. Smoking, liquor consumption and used of pan masala is totally banned in college campus & hostel. Anyone found guilty will be punished and will restrain to appear in final exam.
13. If any student is found to breach the discipline in college/ hostels, he/she may be expelled from the hostel with an adverse entry in the character certificate for which he/she will be solely responsible.
14. If any student is found indulging in ragging, he/ she will be given liberty to explain & if his explanation is not found satisfactory, the authorities will take suitable punitive action which includes (a) expulsion from the hostel, (b) stoppage of scholarship, (c) lodging of FIR, (d) expulsion from Institute (as per directive of Supreme court)
15. Each student will submit character certificate from last institution.
16. The college has anti-ragging squad & disciplinary committee to look into the matter with ragging & will submit the report to the principal.
17. Each student and his guardian has to give an undertaking each year for not to indulge in ragging as per format attached in prospectus.
18. Any food or drinks are not allowed from outside in hostel premises.
19. Students are advised to switch off light and for before leaving the room.
20. Students has to reach college at 9:00 am in proper dress and shoes.

## ADVICE TO PARENTS / GUARDIANS

Parents/ guardians of the students are advised to keep a close watch on the activities and the performance of their wards. Parents are also advised not to yield to their wards for use of a vehicle in the college campus. Parents are welcome to contact the principal in person between 2 p.m. to 4:00 p.m. On any working days with prior appointment.

### GENERAL RULES

1. All students shall have to abide by the rules and regulations of the college and the college and hospital promulgated from time to time.
2. As per directives of Hon'ble Supreme Court of India, Government of India and the Government of U.P., ragging in any form invites expulsion, suspension or fine with a public apology or public action as the case may be.
3. Dignity of the profession must be respected. Use of undignified, vulgar offensive or abusive language is strictly prohibited.
4. Each student shall have to undertake the Hippocratic Oath vis-à-vis medical ethics.
5. Students shall have to pay for any damages caused by them to college/Hospital property.
6. College timing shall have to be strictly followed. Parents should assure 80% attendance of their wards compulsory.
7. Hostel rules are to be strictly followed by all hostel inmates.
8. No student should be found in hostel during college timing except on sickness, Which will be authorized by CMO/ CMS of Hind Hospital only.
9. The campus is well designed hence motorcycle/car will not be allowed in the campus. If found guilty vehicle will be confiscated without any notice.
10. Parents are allowed to meet their ward only on Saturday/Sunday. Any interference of parents during working days will be treated as the anti-establishment activity which may cause hindrance in an internal assessment of your ward.

## COLLEGE DAY CUM CONVOCATION:-

College day cum convocation is being celebrated every year.

Training Period and Time Distribution:

1. Every student shall undergo a period of certified study extending over academic years divided into 9 semesters (i.e. of 6 months each) from the date of commencement of his study for the subjects comprising the medical curriculum to the date of completion of the examination and followed by one year compulsory rotatory internship as per MCI rules.
2. The period of years is divided in to three phases as follows:-

- a. Phase I (Two semesters)

Consisting pre-clinical subject (Human Anatomy, Human Physiology including Bio-physics, Bio chemistry, and introduction to Community Medicine including Humanities.)

- b. Phase II (Three semesters)

Consisting of Para-clinical subjects.

During this phased teaching of Para-Clinical and clinical subjects shall be done concurrently.

The para-clinical subjects shall consist of Pathology, Pharmacology, Microbiology, Forensic Medicine including Toxicology and part of Community Medicine. The clinical subjects shall consist of all those detailed below in phase III.

- c. Phase III (Continuation of study of clinical subjects for seven semesters after passing Phase-I)

The clinical subjects to be taught during Phase II and III are Ophthalmology, Otolaryngology, Community Medicine, Medicine and its allied specialties, Surgery and its allied specialties, Obstetrics and Gynecology and Pediatrics.

The Medicine and its allied specialties' training will include General medicine, Tuberculosis and Chest, Skin and Sexually Transmitted Diseases, Psychiatry, Radio-diagnosis, infectious diseases etc. The Surgery and its allied specialties' training will include General surgery, Orthopedics, Physiotherapy and rehabilitation, Anesthesia, Dentistry, Radiotherapy etc. The Obstetrics and Gynecology training will include family medicine, family welfare planning etc.

## Internship for 1 year:-

The Internship is a phase of training where in a graduate is expected to conduct actual practice of medical and healthcare and acquire skills under supervision so that he/she may become capable of functioning independently.

The Intern shall maintain a record of work which is to be verified and certified by the medical officer under whom he works. Apart from the scrutiny of the record of work, assessment and evaluation of training shall be undertaken by an objective approach using situation tests in knowledge, skill and attitude during and at the end of training. Based on the record of work and date of evolution, the Dean/Principal shall issue the certificate of satisfactory completion of training, following which the university shall award the M.B.B.S. degree and the intern is eligible for obtaining the permanent medical registration from the competent authority.

## EXAMINATION:-

The performance is the essential component of training.

Eligibility to appear in a professional examination as per MCI regulation-

- (a) Attendance: 75% of attendance in a subject for appearing in the examination is compulsory including non-lecture teachings (practical/clinics/tutorials). A student having attendance of less than 75% will not be allowed to appear in the final examination.

### (b) Internal Assessment:

- (I) It shall be based on periodic terminal examination, practical, day to day assessment, evaluation of student assignment, preparation for the seminar, clinical case presentation etc.
- (II) The Student must secure at least 50% marks of total fixed for internal assessment in a particular subject in order to be eligible to appear in final university Examination of that subject.

### A. UNIVERSITY EXAMINATION:

The college is affiliated to Dr. RML Awadh University, Faizabad for examination. There shall be one main examination in a year and a supplementary examination to be held not later than 6 months after the publication of its results. University examination shall be held as under:

#### PHASE 1 First Professional (1-2 semester):

In the second semester of Phase-I training in the subject of Anatomy, Physiology and Biochemistry.

#### PHASE 2 Second Professional (3-5 semester):

In the fifth Semester of Phase-II training in the subject of Pathology, Microbiology, Pharmacology and Forensic Medicine.

#### PHASE 3 (a) Third Professional (6-7 semester):

##### Final Professional Part-I:

In the seventh semester of Phase-III training in the subject of Ophthalmology, Otolaryngology and Community Medicine.

#### PHASE 3 (b) Third Professional (8-9 semester):

##### Final Professional Part-II:

At the end of Phase-III training in the subject of Medicine, Surgery, Obstetrics, Gynecology and Pediatrics.

### NOTE:

- (a) Passing in Ist Professional is compulsory before proceeding to Phase-II training.
- (b) A student who fails in the II<sup>nd</sup> Professional Examination shall not be allowed to appear in III<sup>rd</sup> Professional Part I examination unless he/she passes all subjects of II<sup>nd</sup> Professional examination.
- (c) Passing in III<sup>rd</sup> Professional (Part-I) examination is not compulsory before entering for 8<sup>th</sup> and 9<sup>th</sup> semester training, however passing of III<sup>rd</sup> Professional (Part-I) is compulsory for being eligible for III<sup>rd</sup> Professional (Part-II) examination.
- (d) Students with shortage of attendance (75% in theory and Practical/Demonstration/Tutorials and Clinical) will not be allowed to appear in University Examination. Mass Bunk will be treated as Absent and may be liable to the extension of course duration.
- (e) In each of the subject, a candidate must obtain 50% in aggregate with a minimum of 50% in theory including oral and minimum 50% in Practical/Clinical.
- (f) To encourage in excellence in academics we provide following incentives:

### LIST OF ACADEMIC PRIZES IN PROFESSIONAL EXAMINATION:

#### (A) MERIT CERTIFICATES

- (I) Certificate of merit and cash prize of Rs. 25,000 for standing FIRST in each Professional examination.
- (II) Certificate of merit and cash prize of Rs. 15,000 for standing SECOND in each Professional examination.
- (III) Certificate of merit and cash prize of Rs. 10,000 for standing THIRD in each Professional examination.
- (IV) Certificate of merit for standing FIRST in each subject.
- (V) Certificate of merit for securing DISTINCTION in each subject.
- (VI) Certificate of merit for securing HONOURS in each subject (Maximum four).

#### (B) GOLD MEDALS
